# **FYI Report Q&A:**

New scales – All scales are being brought up to FDS standards.

Staff Evaluations – It has been several years since staff evaluations were completed, and Matt appreciates touching base with every manager and coordinator. The Board discussed whether staff surveys have been completed in the past. The Board and the GM considered the possibility of using a third-party facilitator to conduct the Staff Treatment & Compensation Report. The Board is eager to look further into this possibility and identified additional factors to consider, such as budget, frequency, and how to continue fostering open communication among staff.

Marketing Initiatives – The Marketing team and Wellness Coordinator are working on developing an annual marketing plan, which will serve as a communication tool and increase transparency between departments. The annual plan will include sales data, monthly promotional themes, an outreach calendar, and other details.

Prepared Foods – The Prepared Foods Department is working on a new catering menu and looking into partnering with a local courier service to offer a delivery option.

### **GM Monitoring Report: Annual Ends Monitoring Report:**

The GM shared reflections on the experience of writing the monitoring report, largely following the format from previous reports and adding personal interpretations.

The GM highlighted sustainability data and plans to include details in this year's annual report.

The GM shared ideas for connecting staff work with the Ends, such as recreating a public calendar and including the Ends or Annual Report in onboarding.
